Our flagship initiative, the THC-Powered Telemedicine Network, connects underserved communities with affordable and Al-driven telemedicine services. revolutionizing access to healthcare. With payments facilitated through \$THC tokens, this project empowers individuals while driving token adoption.

Over the past three years, Transhuman Coin has funded transformative longevity research in Australia and Africa, addressing critical challenges in the fight against aging and disease. Our investments include supporting the FoxG1 Foundation Australia, advancing genetic solutions for neurological conditions, and funding groundbreaking innovations like Abby-Wheelchairs, a project developing autonomous wheelchairs for enhanced mobility.



Transhuman Coin is a BEP20 token dedicated to solving difficult human problems using technologies by funding Reseach and Development of Technologies that augment or increase human sensory reception, emotive ability, cognitive capacity, reverse ageing as well as radically improve human health and extend human life spans.

In 3 years after launching, we have successfully funded projects funded like the FOXG1 Foundation, Abby Autonomous Wheelchairs and multiple Science Events across the world including Hackathons at the University of Technology, Sydney, Australia, Transvision Madrid, Spain 2022 on Longevity and Cryonics, International Longevity Summit, South Africa hosted by TAFFD and the Evolve Conferences in Lagos and Abuja, Nigeria. We have funded research through multiple universities in Africa and Australia including Abia State University, Uturu, Nigeria and University of Technology, Sydney.

Transhuman Coin is a blockchain based project that invests in Future Human Technologies. We are futuristic. We are a community of Futurists inspired by concepts like Singularity and Transhumanism. We research, develop, invest and own Intellectual Properties in fields like Artificial Intelligence, Robotics, Virtual and Augmented Reality including the Metaverse, Brain Computer Interface Technologies and Sci-fi movies.

To ensure the viability of the project long term a small portion of each transaction goes into the longevity and stability of the project: 0.5% will automatically go into the locked liquidity pool





## Transhuman Coin Funds

Our funding system is a groundbreaking new system designed to revolutionize project funding. We are revolutionizing the way Transhumanist Causes are funded.

Our vision is to use the \$THC funding vehicle to provide an ongoing financing for Transhumanist projects deemed appropriate for support by our community in exchange for equity or Intellectual Property. We are striving to combat diseases and aging. Our community decides who and what we invest in - voting on a decentralized platform using their \$THC. Those with more \$THC have more voting power.

By using the blockchain system to vote for Transhumanist and Longevity Causes, our system provides complete transparency towards our funding and donations and reflects shareholders' voices. All fundings are made in \$THC and beneficiaries are advised to hold the \$THC on their balance sheet for a minimum period of 12 months.

## THC WEB3 CLINIC

The THC-Powered Telemedicine Network is a revolutionary healthcare platform enabling affordable, AI-driven medical consultations and diagnostics, powered by Transhuman Coin (\$THC). This network connects underserved communities, particularly in Africa, to top-tier healthcare providers through a decentralized ecosystem. Patients can book consultations, access health monitoring tools, and receive diagnostic services, all paid seamlessly using \$THC tokens. By combining blockchain technology with telemedicine, this initiative improves healthcare accessibility, promotes token adoption, and drives impactful change in global health.

#### Blockchain-Powered Accessibility

Not everyone can get worldclass medical care, but with blockchain enabled Medical Care Platform, we eliminate reliance on traditional financial systems to fund medical care, reducing transaction fees and making healthcare accessible to underserved populations, particularly in regions with limited banking infrastructure like Africa.

#### AI-Powered Diagnostics and Care

The network incorporates AI to enhance diagnostics and personalize treatment recommendations. Advanced algorithms analyze patient data, improving accuracy and speed in diagnosing health issues.

#### Enhanced Revenue and Global Reach for Practitioners

Medical practitioners benefit from direct access to a global patient base, removing geographical barriers. The decentralized payment model using \$THC tokens ensures prompt, secure, and low-cost payments, increasing earnings by bypassing intermediaries.

### **THC Lending/ Borrowing**

The architecture of lending and borrowing is about to be significantly disrupted by THC. We don't need banks or other intermediaries to complete a loan transaction as we decentralize lending. Decentralization also implies that once a Smart Contract is launched, borrowers and lenders trust it. These lending protocols offer a risk-free and transparent lending environment that is currently unavailable in the FIAT lending industry. No one can interfere with, interrupt, or alter the loan after it has been deployed, which is referred to as "trustless."


Through our partners, THC holders will lend and borrow Stablecoins using their THC as collateral. Lenders profit from interest, while borrowers can obtain loans fast and discreetly without having to deal with them personally.

Lending or borrowing against \$THC is better suited to users who desire low-risk economic benefits with confidentiality. Lending is an ideal match for holders who want to keep their tokens while also earning extra money.

You might be concerned: what if the person who borrowed my cryptocurrency refuses to repay it? The point is, borrowing on decentralized Lending Protocols necessitates collateral, which assures that the lenders are paid in full for the principal and interest.

Users of decentralized lending services can apply for any size loan without having to verify their identity with a third party. Transhuman Coin will be used to back loans.

Dr. Avinash Singh is an Australian Research Council Postdoctoral Research Fellow at the Australian Artificial Intelligence Institute (formerly known as Centre for Artificial Intelligence) in University of Technology Sydney (UTS), Australia, and Founder of India Future Society.



He is also a member of Transhumanism Australia and actively advocate and promote Transhumanism. Dr Singh completed his Ph.D. degree in Computer Science in 2019 from UTS, Australia in collaboration and support with Technical University of Berlin, Germany, University of California San Diego, USA, and US Army Research Lab. Before his doctorate, Dr. Singh received his Bachelor's degree in Mathematics in 2007 from Chhatrapati Shahu Ji Maharaj University, India, and Master's in Software Systems in 2013 from Birla Institute of Technology and Science Pilani, India. During these years of study and work, Dr. Singh worked on various topics in human-centered technologies focusing on braincomputer interfaces (BCIs).

Dr Singh has developed several systems such as 'Web-browser for blinds based on natural language processing,' 'A brain-computer interface (BCI) system for communication,' 'An eating-assistant system for the user with a disability,' 'A closed-loop system to evaluate and adapt user's feeling in Virtual Reality,' etc. He also serves the IEEE Standards committee on Neuroethics and BC, and recently received Google TensorFlow Faculty Award 2021 to support and promote work in BCI.

His current research interests are integrating artificial intelligence (Al) technologies with cognitive neuroscience knowledge to explore the cognitive functions, discover the relationships between brain dynamics, evaluate everyday interaction, and make decisions, and develop robust next- generation of brain-computer interfaces.
